DIRECTIONS FOR READING THIS GENEALOGY

This Family history has information on all of Adam Gohn's twelve children, but is mainly concerned with three sons: Adam, John, and Peter, who migrated to Somerset County, Pa. between 1796 and 1800.

The numbering of individuals and Family groups is as Follows:

(1) Philip Gohn

- (1a) Adam Gohn I, b. ca. 1718. (Father of the five sons listed below) (1b) Adam Gohn II, b. ca. 1739.
- (1c) Henry Gohn, b. ca. 1741.
- (1d) John Gohn, b. ca. 1746.
- (1e) Peter Gohn, b. 1753.
- (1f) Philip Gohn, b. 14 Aug. 1757.

Each individual, about whose family a separate section is written, is prefaced by an Arabic numeral and letter. For example, near the bottom of page 7, the Arabic numeral and letter 3b prefaces the section on the family of John Gohn. The names in the parenthesis after his name refer to his ancestors. Note: John (4) Gohn (Adam II-3, Adam I-2, Philip-1). Explanation: Adam II-3 is John Gohn's father and the 3rd generation in the Family. Philip-1 is the first generation to arrive in the United States.

The children of John Gohn are listed by Roman numerals such as i, ii, iii, etc. Those children, about whose families more has been written, are prefaced by an Arabic numeral and letter in parenthesis. Thus, the first four children of John and Mary Gohn are listed in the following manner: (5b) i Jacob Gohn

- (6b) ii David Gohn (7b(iii Michael Gohn
- (8b) iv Edward Gohn

More has been written about these four in sections marked 5b, 6b, 7b, and Bb with the parenthesis removed. The fifth child, Lydia, as no further information. Thus, she is listed: v Lydia Gohn

The following abbreviations have been used to save space:

b.- born; bapt.-baptized; bur.-buried; ca.-about; cem.-cemetery; Co.-County; d.-died; m.-married; Twp.-Township.

Summer address: Mrs. Wilson McTeer Box 302 Port Austin, Michigan 48456	It is uncertain whether Philip Gohn and mem- bers of his family were born in Rimschweiler or had lived in that area for only a short time. But according to Ralph B. Strassburger and W. J. Hinke, in <u>Pennsylvania German Pio- neers</u> , 1:221, 1934, the Philip Gohn family were among the Palatines who came to America on the ship <u>The Thistle</u> arriving at the Port of Philadelphia 19 Sept. 1738.
	There has been some uncertainty about the relationship of Philip (Fielip), Adam and John Gohn. Were they brothers or were the latter two sons of Philip? On file in the Court House of Philadelphia is "the sworn statement of John Wilson, Commander, that the above is a true and complete list of the males above 16 years of age imported on the ship <u>The Thistle</u> ." The following names were among those on the list: Adam Gohn, Johannes [H) Gohn, and Fielip Gohn. Since Adam and John Gohn were included on the passenger list, it is obvious that they were over 16 years of age.
	The Pennsylvania German Folklore Society, Yearbook, 1:122, lists the immigrants from Rimschweiler, Zweibrucken in the Palatinate who departed on the ship The Thistle in 1738. Among those included were Conrad Dietz of Althornbach, Philipp Gohn of Rimschweiler and four others from the same place; all six leave with their wives and children for America. George Brahr of Rimschweiler leaves for America with his son-in-law, Philipp Gohn. Here Adam and John are grouped as children of Philipp. The name of Philip Gohn's first wife is un- known. His second marriage was to Marla Sophia 8raher, daughter of George Braher, who came to America with his son-in-law on the ship, The Thistle in 1738. As the widow of Philip Gohn, Maria Sophia Gohn remarried about 1746 to Vitus Behner.

ii John Gohn, b. ca. 1720. He came to the United States with his parents on the ship <u>The Thistle</u> 19 Sept. 1738. Since two or more of John's descendants are working on their family history, the present volume will be a record of the descendants of Adam's twelve children but chiefly of the three sons, Adam Jr., John and Peter, who left York Co., Pa., about 1800 and migrated to Somerset Co., Pa.

Adam (2) Gohn (Philip-1), b. in Germany. Lived for some years in Rimschweiler, Zweibrucken, in the Palatinate, Germany; d. before the 16 Nov. 1773; m. Maria Catharine; d. before 21 Jan. 1791, Windsor Twp., York Co., Pa.

As previously stated, it is unknown whether Philip was the father or brother of Adam and John. Since most of the records of that area were destroyed during World War II, it is doubtful whether accurate records can be obtained. Adam is placed here as the son of Philip. The list of emigrants from Rimschweiler, on the ship The Thistle, Pennsylvania Folklore Society, 1:22, includes Philip Gohn alone, but all three, Philip, Adam and Johannes appear on the passenger list of The Thistle arriving in Philadelphia 19 Sept. 1738. Pennsylvania German Pioneers, 1934, by Ralph S. Strassburger and J. J. Hinke, 1:221.

In York County Adam Gohn lived in Windsor Twp. where he had a considerable plantation; he was a member of Canadochly Church and an overseer of the Township in 1759 and 1760. According to the Miscellaneous Land Papers in the possession of the. Historical Society of York Co. (No. 12784), an additional tract in Chance ford Township named "Deerfield" was surveyed in November 1768 for Adam Gohn (no acreage or lacation in the record is given).

The will of Adam Gohn, Yoeman, Windsor Twp., dated 30 May 1766, probated 16 Nov. 1773, mentions his wife, Catherine and children Adam, Henry, Sophia, Catherine, John, Elizabeth, Mary, Magdalena, Peter, Margaret, and Philip. Executors: Wife Catherine and son Henry (York Co., Penna., Will Book 0: 189). On 25 March 1775 the estate of Adam Gohn showed a balance of (80.0.0½). There is no later record of distribution. (York Co., Penn., Administration Accounts).

According to the 1783 list of taxables for Windsor Twp., the Widow Gohn had 250 acres of land there, a house, two outhouses and three inhabitants (probably besides herself, the two unmarried daughters). In the 1790 Census

she is listed in York Twp., with a household of three females. But Catherine was probably dead by 21 Jan. 1791, when her daughter Sophia deeded away her share of her father's plantation held subject to her mother's life interest.

All of Adam Gohn's eleven surviving children seem to have remained in York Co. until the end of the Revolutionary War. Sons Adam, Henry and Philip are clearly discernable in the 1790 Census. But only Philip's family can be traced in the later York Co. records. Adam's daughter, Sophia, moved to Virginia before 1791; perhaps some of her brothers went in that direction, also.

The names of Adam, John and Peter Coan appear on the 1800 Quemahoning <u>Somerset</u> <u>Co.</u>, <u>Pennsylvania</u> <u>Taxation Assessment</u> <u>Roll</u>, 1795-1817. They were also included in the 1800 Quemahoning census. Their descendants say these men came from York Co., Pa., where they fought in the Revolutionary War.

According to the Deed Book v. 20, p. 374, York Co. Pa., Sophia and her husband, Conrad Lear, lived in Shenandoah, Va. in 1791. "On the 21 Jan. 1791, ' Conrad Lear and Sophia, his wife (late Sophia Gohn) of the County of Shenandoah, Virginia, the said Sophia being a daughter heir and devises" of Adam Gohn, late of Windsor Township, York Co., Pa. Deceased: "(paid to) Jacob K. Kauffelt of Windsor Twp.:...all the grantors share in a certain plantation and tract of land in

Windsor Twp. whereof the said Adam Gohn died siezed; after the decease of Catherine Gohn, widow and relict of the said. Adam, deceased."

- iv Maria Catharine Gohn, b. ca. 1744 in Windsor Twp. York Co, Pa., m. Michael Albright, Jr. Catharine and her daughter, Rebecca, were mentioned in her sister Margaret's Will.
- (1d) v John Gohn, b. ca. 1746.
 - vi Elizabeth Gohn, b. 1748, Windsor Twp., York Co., Pa. She and a daughter, Marcrate, were mentioned in her sister Margaret's Will.
 - vii Anna Mary Gohn, b. ca. 1750; mentioned in her sister Margaret's Will.
 - viii Mary Magdalena Gohn, b. 2 Oct. 1751, bapt. 18 May 1752 in the Christ Lutheran Church, York Co., Pa.; sponsors, Jacob Fackler and wife and Mary Magdalena; m. -- Neaf. Mary Magdalena and their three children, Jacob, Abraham, and Rebecca Neaf, were mentioned in her sister's Will.
- (1e) ix Peter Gohn (Goan, Coan) , b. 1753.
 - x Maria Barbara Gohn, b. 17 Sept. 1754; bapt. 16 Mar. 1755 in the Conejohela Church in Lower Windsor Twp.; sponsors, Maria Barbara Schmelzer, Veit Behner and his wife; parents, Adam and Maria Catharina Gohn. Maria Barbara was not mentioned in her Father's or her sister's Will. Therefore, her death must have occurred before 1766.
 - xi Maria Margaretha Gohn, b. 24 May 1756; bapt. 22 June 1756 at the Conejohela Church in Lower Windsor Twp., York Co., Pa;: sponsors, Maria Sophia Behner, Ludwig Meyer and his wife Margaretha. Her death evidently occurred in 1787 as
